THE NORTHERN TERRITORY OF AUSTRALIA

AN ACT

To amend the Electricity Commission Act

[Assented to 9 January 1981]

B^E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the <u>Electricity Commission Amendment</u> Act 1980.

2. PRINCIPAL ACT

The <u>Electricity Commission Act</u> is in this Act referred to as the Principal Act.

3. COMMENCEMENT

This Act shall come into operation on the date of commencement of the Mines Safety Control Act.

4. NEW SECTION

The Principal Act is amended by inserting after section 3 the following section:

"3A. EXEMPTION OF MINES

"Parts III and IV of this Act do not apply to a mine within the meaning of the Mines Safety Control Act.".

5. ELECTRICAL INSPECTORS

Section 19(2) of the Principal Act is amended by omitting "Mining Ordinance" and substituting "Mines Safety Control Act".

6. BY-LAWS

Section 26 of the Principal Act is amended by omitting subsections (4) and (5).

7. FURTHER AMENDMENTS

The provisions of the Principal Act specified in Column 1 of the Schedule are amended as set out in Column 2 of the Schedule in relation thereto.
