AN ACT

To amend the Leprosy Act

[Assented to 9 January 1981]

- **B**^E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:
 - 1. SHORT TITLE

This Act may be cited as the Leprosy Amendment Act 1980.

2. PRINCIPAL ACT

The Leprosy Act is in this Act referred to as the Principal Act.

3. REPEAL AND SUBSTITUTION OF SECTIONS 22 AND 23

Sections 22 and 23 of the Principal Act are repealed and the following sections substituted:

"22. POWERS OF CHIEF MEDICAL OFFICER REGARDING ENTRY TO LEPROSARIUM

"The Chief Medical Officer may -

- (a) enter or remain in a leprosarium; and
- (b) authorize a person to enter or remain in a leprosarium,
- "23. OFFENCE TO ENTER LEPROSARIUM

"A person shall not enter or remain in a leprosarium unless -

- (a) he is the Superintendent of that leprosarium;
- (b) he is a leprosy patient; or
- (c) he is authorized to be or remain in a leprosarium by or pursuant to section 22.".
- 4. AMENDMENTS

The Principal Act is amended as set out in the Schedule.
