BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

Trustee Act (No. 2) 1978.

Short title

2. The <u>Public Trustee Ordinance</u> is in this Act referred to as the Principal Act.

Principal Act

3000The Principal Act is amended by inserting after section 2 the following section:

- (c) in respect of such rents 3 per centum.".

Application

5. The Schedule to the Principal Act as amended by this Act does not apply to or in relation to the administration of the estate of a person who died before the commencement of this Act.
