# AN ACT

Relating to the revision of certain statutes

[Assented to 2 February 1979]

**B**<sup>E</sup> it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

1. This Act may be cited as the <u>Statute Law</u> Revision Act (No. 2) 1978.

2. The <u>Building Act</u> is amended by omitting from section 9A(3)(b) "the person who is for the time being holding or performing the duties of the office of the Director of Lands, Department of the Interior, in the Northern Territory" and substituting "the Departmental Head of the Department or the Minister".
