Act No. 24 of 2025

An Act to amend the *Gaming Control Act 1993*

[Assented to 12 September 2025]

[Introduced 30 July 2025]

The Legislative Assembly of the Northern Territory enacts as follows:

1 Short title

This Act may be cited as the *Gaming Control Amendment (Community Benefit Fund) Act 2025*.

2 Commencement

- (1) Subject to subsection (2), this Act commences on the day fixed by the Administrator by *Gazette* notice.
- (2) If a provision of this Act does not commence before 26 July 2027, it commences on that day.

3 Act amended

This Act amends the *Gaming Control Act 1993*.

4 Section 3 amended (Definitions)

- (1) Section 3, definition **major grant**

omit, insert

major benefit means:

- (a) a benefit that has a monetary value that is greater than the monetary value of a minor benefit but not more than the amount determined by the Minister under section 68A(4)(a); or
- (b) a benefit that is a motor vehicle.

- (2) Section 3, definition **minor grant**

minor benefit means a benefit that has a monetary value that is not more than the amount determined by the Minister under section 68A(4)(b).

5 Section 68A amended (Community Benefit Fund)

- (1) Section 68A(2)(c)

omit, insert

- (c) funding of the following benefits:

- (i) grants for community projects and services of benefit to communities throughout the Territory;
- (ii) capital works or improvements to land or a building, structure or erection owned by the Territory that is occupied by a not-for-profit organisation for the purpose of delivering community projects and services of benefit to communities throughout the Territory;
