# NORTHERN TERRITORY OF AUSTRALIA

## AN ACT

to amend various legislative provisions consequential on the enactment of the *Northern Territory Employment and Training Authority Act 1999*

[Assented to 1999]

[Second reading 1999]

**The Legislative Assembly of the Northern Territory enacts as follows:**

**1. Short title**

This Act may be cited as the *Northern Territory Employment and Training Authority (Consequential Amendments) Act 1999*.

**2. Commencement**

This Act comes into operation on the commencement of the *Northern Territory Employment and Training Authority Act 1999*.

**3. Amendment of *Batchelor Institute of Indigenous Tertiary Education Act 1999***

Section 10 of the *Batchelor Institute of Indigenous Tertiary Education Act 1999* is amended by omitting subsection (3)(j) and substituting the following:

- "(j) a person who has specialist knowledge or skills, and current experience, in the delivery of vocational education and training programs to Aborigines and Torres Strait Islanders in remote areas and who is nominated by the Northern Territory Employment and Training Board established under the *Northern Territory*

*Northern Territory Employment and Training (Consequential Amendments) Act 1999*

*Employment and Training Act* to represent the interests of Aborigines and Torres Strait Islanders;".

**4. Amendment of Pay-roll Tax Regulations**

(1) Regulation 27S of the Pay-roll Tax Regulations is amended by omitting from subsection (1)(a) "probationers and trainees" and substituting "apprentices".

(2) Regulation 27S of the Pay-roll Tax Regulations as amended by subsection (1) may be amended or repealed by a regulation as if the amendment had been made by a regulation under that Act.

**5. Amendment to Agents Licensing Regulations**

(1) Regulation 9 of the Agents Licensing Regulations is amended by adding at the end of subregulation (2) "as in force immediately before the commencement of the *Northern Territory Employment and Training Authority Act 1999*".

(2) Regulation 9 of the Agents Licensing Regulations as amended by subsection (1) may be amended or repealed by a regulation as if the amendment had been made by a regulation under that Act.
