The Legislative Assembly of the Northern Territory enacts as follows:

1. Short title

This Act may be cited as the Statute Law Revision Act (No. 2) 2003.

2. Commencement

- (1) Part A of the Schedule comes into operation on the commencement of the Associations Act 2003.
- (2) Part B of the Schedule comes into operation on the commencement of section 3 of the *Business Tenancies (Fair Dealings) Act 2003*.
- (3) The remaining provisions of this Act come into operation on the day on which the Administrator's assent to this Act is declared.

3. Amendments of Territory laws

(1) The laws specified in the Schedule are amended as set out in the Schedule.
