## NORTHERN TERRITORY OF AUSTRALIA

# A BILL for AN ACT

to amend the *Mining Act*

**B**E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Mining Amendment Act (No. 3) 1998*.

2. COMMENCEMENT

This Act comes into operation on the date fixed by the Administrator by notice in the *Gazette*.

3. PRINCIPAL ACT

The *Mining Act* is in this Act referred to as the Principal Act.

4. INTERPRETATION

Section 4 of the Principal Act is amended —

- (a) by omitting from subsection (1) the definition of "mineral field";
- (b) by omitting from subsection (1) the definition of "prescribed mining registrar's office";

(c) by inserting after the definition of "Crown land" from subsection (1) the following:

"'Department' means the Agency responsible for administering this Act;" and

(d) by omitting from the definition of "private land" in subsection (1) "*Conservation Commission Act*" and substituting "*Parks and Wildlife Commission Act*".

5. REPEAL

Section 8 of the Principal Act is repealed.

6. ESTABLISHMENT OF COURTS

Section 141 of the Principal Act is amended by omitting subsection (1) and substituting the following:

"(1) There is established a warden's court at each prescribed place in the Territory."

7. PRIORITY IN CONSIDERING APPLICATIONS

Section 164 of the Principal Act is amended -

(a) by omitting from subsection (4) all words after "that is received" and substituting "by the Department after close of business on a particular day is to be taken to be lodged on the next day the Department is open for business."; and

(b) by omitting from subsection (5) "an office of the Secretary or a mining registrar is" and substituting "offices of the Department are".

8. CAVEAT

Section 174 of the Principal Act is amended -

(a) by omitting subsection (1);

(b) by omitting from subsection (2) "in the prescribed form at the prescribed office, a caveat" and substituting "with the Department a caveat in the prescribed form";

(c) by omitting from subsection (3) "in the Territory";

(d) by omitting from subsection (4) all words after "is received" and substituting "by the Department.";

- (e) by omitting from subsection (5) "or mining registrar, as the case may be," and substituting "or his or her delegate";
- (f) by omitting subsection (8) and substituting the following:

"(8) Where a notice under subsection (7) has been served on a caveator, he or she may, on payment of the prescribed fee, lodge with the Department in the prescribed form a notice of continuation of the caveat and the caveat remains in force in respect of all purported dealings with the exploration licence, exploration retention licence or mining tenement, as the case may be, except that in respect of which the notice under subsection (7) was given, and the Secretary or his or her delegate must record the notice of continuation accordingly."; and

- (g) omitting from subsection (9) "at the prescribed office," and substituting "with the Department,".

9. SERVICE OF DOCUMENTS

Section 188 of the Principal Act is amended by omitting from subsection (3) "at the office of the Secretary," and substituting "used for notices to the public at the Department,".

10. REGULATIONS

Section 192 of the Principal Act is amended by omitting from subsection (2)(g) "procedure and practice" and substituting "location, procedure and practice".

11. FURTHER AMENDMENTS

The Principal Act is amended as set out in the Schedule.
