# AN ACT

to amend various Acts and Rules consequential on the enactment of the Personal Injuries (Liabilities and Damages) Act

[Assented to 2002] [Second reading 2002]

### The Legislative Assembly of the Northern Territory enacts as follows:

#### 1. Short title

This Act may be cited as the Personal Injuries (Liabilities and Damages) (Consequential Amendments) Act 2002.

#### 2. Commencement

This Act comes into operation on the date, or respective dates, fixed by the Administrator by notice in the *Gazette*.

#### 3. Amendment of Law Reform (Miscellaneous Provisions) Act

- (1) Sections 10 and 10A of the Law Reform (Miscellaneous Provisions) Act are repealed.
- (2) The repeal effected by subsection (1) does not apply in relation to an act or omission of an occupier causing a personal injury to a person
  - (a) that occurred before the commencement of this section; and

#### Personal Liabilities (Liabilities and Damages) (Consequential Amendments) Act 2002

- (b) that, but for section 10A of the Law Reform (Miscellaneous Provisions) Act, may have given rise to a breach of the common law duty of care.
- (3) In this section –

"personal injury" includes a fatal injury, a prenatal injury, a psychological or psychiatric injury, a disease and the aggravation, exacerbation or acceleration of a pre-existing injury.

#### 4. Amendment of Local Court Act

Section 21 of the *Local Court Act* is amended by omitting from subsection (2)(f) "provide" and substituting "subject to Part 4 of the *Personal Injuries (Liabilities and Damages) Act*, provide".

#### 5. Amendment of Local Court Rules

- (1) Rule 39.03 of the Local Court Rules is amended by inserting after subrule (1) the following:
- "(1A) Subrule (1) applies subject to Part 4 of the Personal Injuries (Liabilities and Damages) Act.".
- (2) The rule amended by subsection (1) may be amended or repealed by a rule as if the amendment had been made by a rule.

#### 6. Amendments of Supreme Court Act

- (1) Section 29 of the Supreme Court Act is amended by omitting from paragraph (c)(i) "order" and substituting "subject to Part 4 of the Personal Injuries (Liabilities and Damages) Act, order".
- (2) Section 84 of the *Supreme Court Act* is amended by inserting after subsection (1) the following:
- "(1A) Subsection (1) applies subject to Part 4 of the Personal Injuries (Liabilities and Damages) Act.".
