# NORTHERN TERRITORY OF AUSTRALIA

## AN ACT

to amend various legislation consequent on the enactment of the *Northern Territory Employment and Training Authority Amendment Act 2002*

[Assented to 2002]

[Second reading 2002]

The Legislative Assembly of the Northern Territory enacts as follows:

**1. Short title**

This Act may be cited as the *Northern Territory Employment and Training Authority (Consequential Amendments) Act 2002*.

**2. Commencement**

This Act comes into operation on the day on which, but immediately after, the *Northern Territory Employment and Training Authority Amendment Act 2002* commences.

**3. Amendment of *Batchelor Institute of Indigenous Tertiary Education Act***

Section 10 of the *Batchelor Institute of Indigenous Tertiary Education Act* is amended by omitting from subsection (3)(j) "the Northern Territory Employment and Training Board" and substituting "the Ministerial Advisory Board for Employment and Training".

*Northern Territory Employment and Training Authority (Consequential Amendments) Act 2002*

**4. Amendment of *Education Act***

Section 4 of the *Education Act* is amended by omitting from the definition of "Authority" in subsection (1) "Authority".

**5. Amendment of *Public Sector Employment (Interim Arrangements) Act***

Schedule 2 to the *Public Sector Employment (Interim Arrangements) Act* is amended by omitting "Authority".

**6. Amendment of *Agents Licensing Regulations***

Regulation 10AC of the *Agents Licensing Regulations* is amended by omitting "Authority".

**7. Amendment of *Pay-roll Tax Regulations***

Regulation 27S of the *Pay-roll Tax Regulations* is amended by omitting from subregulation (1)(a) "Authority".

**8. Amendment by regulation authorised**

A regulation amended by section 6 or 7 may be amended or repealed by a regulation as if the amendment had been made by a regulation.
