# NORTHERN TERRITORY OF AUSTRALIA

## AN ACT

to amend various Acts and Regulations consequential on the enactment of the  
*Sentencing Amendment Act (No. 3) 2001*

**The Legislative Assembly of the Northern Territory enacts as follows:**

**1. Short title**

This Act may be cited as the *Sentencing (Consequential Amendments) Act 2001*.

**2. Commencement**

This Act comes into operation on 22 October 2001.

**3. Amendment of *Prisons (Correctional Services) Act***

(1) Section 5 of the *Prisons (Correctional Services) Act* is amended by omitting the definition of "community service order" and substituting the following:

" 'community work order' means a community work order made under the *Sentencing Act*;"

(2) The heading to Division 2 of Part XXVIA is amended by omitting "*Service Orders*" and substituting "*work orders*".

*Sentencing (Consequential Amendments) Act 2001*

(3) Section 94E of the *Prisons (Correctional Services) Act* is amended by omitting "community service" (wherever occurring) and substituting "community work".

(4) Section 101(3)(b) of the *Prisons (Correctional Services) Act* is amended by omitting "community service" (wherever occurring) and substituting "community work".

**4. Amendment of *Work Health Act***

Section 3 of the *Work Health Act* is amended by omitting from subsection (4) all words before and including "shall be deemed" and substituting "A natural person performing work under a community work order under section 53(1)(e) of the *Juvenile Justice Act* is to be taken".

**5. Repeal**

The Sentencing (Punitive Work Orders) Regulations are repealed.

**6. Amendment of Regulations**

(1) The Regulations specified in the Schedule are amended as set out in the Schedule.

(2) A regulation amended as set out in the Schedule may be amended or repealed by a regulation as if the amendment had been made by a regulation.
