NORTHERN TERRITORY OF AUSTRALIA

A BILL for AN ACT

to repeal certain laws of the Territory and to revise and correct the law of the Territory in minor aspects

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Statute Law Revision Act (No. 2) 1996*.

2. COMMENCEMENT

(1) Subject to subsection (2), this Act comes into operation on the date fixed by the Administrator by notice in the *Gazette*.

(2) Section 16 comes into operation or is taken to have come into operation on the commencement of the *Meat Industries Act*.

3. REPEAL OF *FEDERAL HOTELS CASINOS (COMPENSATION) ACT*

The *Federal Hotels Casinos (Compensation) Act (No. 37 of 1984)* is repealed.

4. REPEAL OF FOREIGN JUDGMENTS (RECIPROCAL ENFORCEMENT) ACT

The Foreign Judgments (Reciprocal Enforcement) Ordinance 1955 (No. 21 of 1955), the Foreign Judgments (Reciprocal Judgments) Amendment Act 1981 (No. 22 of 1981) and the Foreign Judgments (Reciprocal Enforcement) Amendment Act 1988 (No. 2 of 1988) are repealed.

5. REPEAL OF CERTAIN BY-LAWS

The By-laws specified in Schedule 1 are repealed.

6. AMENDMENT OF ADULT GUARDIANSHIP ACT

Section 7(1) of the Adult Guardianship Act is amended by omitting "Public Service Act" and substituting "Public Sector Employment and Management Act".

7. AMENDMENT OF ELECTRICAL WORKERS AND CONTRACTORS ACT

(1) Section 17A of the Electrical Workers and Contractors Act is amended by omitting subsection (2).

(2) Section 17C of the Electrical Workers and Contractors Act is amended by omitting paragraphs (d) and (e) and substituting the following:

- "(d) investigate and hear complaints relating to electrical work;
- (e) consider matters referred to it by the Minister and to report to the Minister on those matters; and
- (f) consider matters referred to it by the Authority and to report to the Authority on those matters."

8. AMENDMENT OF FINANCIAL MANAGEMENT ACT

The Financial Management Act is amended -

- (a) by omitting from section 6(2)(c) "prescribed" and substituting "specified in the Treasurer's Directions issued under section 38";
- (b) by omitting from section 16(3) "and the Auditor-General"; and
- (c) by omitting from section 23(1) "is received under section 6(2)(b) or (c) into an Operating Account which differs from that estimated in the statement of estimates of receipts and

expenditures by Activity" and substituting "estimated to be received under section 6(2)(b) or (c) into an Operating Account differs from that estimated in the statement of estimates of receipts".

9. AMENDMENT OF *FOOD ACT*

Section 56(3) of the *Food Act* is amended by omitting paragraphs (aa) and (b) and substituting the following:

"(b) determined by the National Health and Medical Research Council, or the Authority within the meaning of the *Australia New Zealand Food Authority Act 1991* of the Commonwealth, and approved by the Council within the meaning of that Act, and as published in the *Commonwealth of Australia Gazette* at a particular time or as published from time to time; or

(c) prescribed or published under a corresponding law relating to the matter dealt with by the Regulations."

10. AMENDMENT OF *FOOD STANDARDS REGULATIONS*

(1) The *Food Standards Regulations* are amended by omitting regulation 3 and substituting the following:

"3. DEFINITION

"In these Regulations, 'Food Standards Code' means the *Australia New Zealand Food Standards Code* within the meaning of the *Australia New Zealand Food Authority Act 1991* of the Commonwealth."

(2) Regulation 3 of the *Food Standards Regulations* may be repealed or further amended by Regulations made under the *Food Act* as if the amendment effected by subsection (1) was made by Regulations under that Act.

11. AMENDMENT OF *HUMAN TISSUE TRANSPLANT ACT*

Section 20(1) of the *Human Tissue Transplant Act* is amended -

(a) by omitting paragraph (a) and substituting the following:

"(a) whose death is or may be a reportable death within the meaning of section 12 of the *Coroners Act*"; and

(b) by omitting paragraph (c) and substituting the following:

"(c) in respect of whose death the Supreme Court has made an order under section 16(3) of the Coroners Act that an inquest be held."

12. AMENDMENT OF JUSTICES ACT

(1) Section 27A of the *Justices Act* is amended -

(a) by omitting from subsection (1)(c) "prepaid certified mail, as provided by the Postal Regulations," and substituting "registered post service, as provided under the Australian Postal Corporation Act 1989 of the Commonwealth,"; and

(b) by omitting from subsection (4)(b) "certified mail, as provided by the Postal Regulations," and substituting "registered post service, as provided under the Australian Postal Corporation Act 1989 of the Commonwealth,".

(2) Section 28 of the *Justices Act* is amended -

(a) by omitting from subsection (4) "certified mail issued under the Postal Regulations" and substituting "registered post service issued under the Australian Postal Corporation Act 1989 of the Commonwealth";

(b) by omitting from subsection (4) "certified mail" (second and third occurring) and substituting "registered post service"; and

(c) by omitting from subsection (5) "certified mail" and substituting "registered post service".

(3) Section 176A(3) of the *Justices Act* is amended by omitting "certified mail" and substituting "registered post service".

13. AMENDMENT OF JUSTICES OF THE PEACE ACT

Section 7(2) of the *Justices of the Peace Act* is amended by omitting "Justice of the Peace" and substituting "justice of the peace".

14. AMENDMENT OF OMBUDSMAN (NORTHERN TERRITORY) ACT

(1) Section 21 of the *Ombudsman (Northern Territory) Act* is amended by omitting "any employee referred to in section 11" and substituting "a person".

(2) Section 31 of the Ombudsman (Northern Territory) Act is amended -

- (a) by omitting from subsection (1) "Neither the Ombudsman nor any employee referred to in section 11 nor any delegate of the Ombudsman shall be" and substituting "The Ombudsman, an employee within the meaning of the *Public Sector Employment and Management Act*, a delegate of the Ombudsman or a person authorized by the Ombudsman is not";
- (b) by omitting from subsection (2) "any employee referred to in section 11 or any delegate of the Ombudsman" and substituting "an employee within the meaning of the *Public Sector Employment and Management Act*, a delegate of the Ombudsman or a person authorized by the Ombudsman"; and
- (c) by omitting from subsection (4) "Neither the Ombudsman nor any employee referred to in section 11 nor any delegate of the Ombudsman shall be" and substituting "The Ombudsman, an employee within the meaning of the *Public Sector Employment and Management Act*, a delegate of the Ombudsman or a person authorized by the Ombudsman is not to be".

15. AMENDMENT OF RIGHTS OF THE TERMINALLY ILL ACT

Section 7(1)(c)(iv) of the *Rights of the Terminally Ill Act* is amended by omitting "subparagraph (ii) - that" and substituting "subparagraph (ii), confirmed that".

16. AMENDMENT OF STOCK DISEASES ACT

Section 11(3) of the *Stock Diseases Act* is amended -

- (a) by omitting "*Abattoirs and Slaughtering Act*" and substituting "*Meat Industries Act*"; and
- (b) by omitting "the *Pet Meat Act*,".

17. REVISION OF OTHER ACTS

The provisions of the Acts specified in Schedule 2 are amended as provided for in that Schedule.

18. REVISION OF REGULATIONS

(1) The provisions of the Regulations specified in Schedule 3 are amended as provided for in that Schedule.

Statute Law Revision (No. 2)

(2) The provisions of the Regulations amended as provided for in Schedule 3 may be repealed or further amended by Regulations as if the amendments effected by subsection (1) were made by Regulations.
