NORTHERN TERRITORY OF AUSTRALIA

A BILL for AN ACT

to amend the Education Act

B^E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory* (Self-Government) Act 1978 of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Education Amendment Act 1996.

2. COMMENCEMENT

This Act shall come into operation on a date to be fixed by the Administrator by notice in the Gazette.

3. DEFINITIONS

Section 10A of the *Education Act* is amended by omitting from the definition of "relevant organisation" the words "section 10C(2)(b)" and substituting "section 10C(2)(c)".

4. COMPOSITION OF BOARD AND APPOINTMENT OF MEMBERS

Section 10C of the Education Act is amended -

- (a) by omitting subsection (2) and substituting the following:
- "(2) Of the members appointed under subsection (1)(b) -

- (a) 3 shall be nominated by the Secretary;
- (b) one (who shall be an employee as defined in the Public Sector Employment and Management Act who is employed as a teacher, including a head teacher, in a college or a school) shall be nominated by the Minister to represent teachers; and
- (c) subject to subsection (3), the prescribed number of members from each of the bodies prescribed for the purposes of this section nominated by those bodies."; and
- (b) by omitting from subsection (3) "subsection (2)(b)" and substituting "subsection (2)(c)"; and
- (c) by omitting from subsection (5) "this section" and substituting "this section,".

5. DISMISSAL OF MEMBERS

Section 10G(3) of the Education Act is amended -

- (a) by omitting from paragraph (a) "Secretary; or" and substituting "Secretary;";
- (b) by inserting after paragraph (a) the following:
- "(b) section 10C(2)(b) the Minister; or"; and
 - (c) by omitting from paragraph (d) "section 10C(2)(b)" and substituting "section 10C(2)(c)".

6. ESTABLISHMENT AND COMPOSITION

Section 11(3) of the Education Act is amended -

- (a) by omitting from paragraph (a) -
 - (i) "10" and substituting "9"; and
 - (ii) subparagraph (i); and
- (b) by inserting after paragraph (ab) the following:
- "(ac) one member (who shall be an employee as defined in the *Public Sector Employment and Management Act* who is employed as a teacher, including a head teacher, in a college or school) nominated by the Minister to represent teachers;".

7. DEPUTY MEMBERS

Section 11A(2)(b) of the *Education Act* is amended by omitting "section 11(3)(ab)," and substituting "section 11(3)(ab), (ac),".

8. TRANSITIONAL

- (1) In this section -
- "Education Act" means the Education Act as in force immediately before the commencement of this Act;

"member" includes a person appointed -

- (a) under section 10C(5) of the Education Act to act from time to time in the place of a member of the Northern Territory Board of Studies during that member's absence or inability to act; or
- (b) under section 11A of the Education Act to be a deputy member to act in place of a member of the Education Advisory Council during that member's absence or inability to act,

as the case may require.

- (2) A person who was, immediately before the commencement of this $\mbox{\em Act}$ -
 - (a) a member of the Northern Territory Board of Studies who was, under section 10C(2)(b) or (5) of the Education Act, nominated by the Australian Education Union (Northern Territory Branch); or
 - (b) a member of the Education Advisory Council who was, under section 11(3)(a)(i) or 11A of the Education Act, drawn from the Australian Education Union (Northern Territory Branch),

shall, on the commencement of this Act, cease to be a member of the Northern Territory Board of Studies or the Education Advisory Council, as the case may be.
