NORTHERN TERRITORY OF AUSTRALIA

A BILL for AN ACT

to amend various Act on the passing of the Fire and Emergency Act 1996

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory* (Self-Government) Act 1978 of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Fire and Emergency (Consequential Amendments) Act 1996.

2. COMMENCEMENT

This Act shall come into operation on the commencement of the Fire and Emergency Act 1995.

3. AMENDMENT OF WORK HEALTH ACT

Section 3 of the Work Health Act is amended -

- (a) by omitting from subsection (8) all words after "Bushfires Act"; and
- (b) by inserting after subsection (8) the following:

"(8A) A natural person who, without remuneration or reward, voluntarily engages in fighting fires or dealing with other emergencies, or training exercises or other activities, as a volunteer member, within the meaning of the Fire and Emergency Act, shall be deemed to be a worker in the employ of the Territory.".
