# A BILL for AN ACT

to amend the Associations Incorporation Act

**B**<sup>E</sup> it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

#### 1. CITATION

This Act may be cited as the Associations Incorporation Amendment (No. 2) Act 1995.

#### 2. INCORPORATION OF ASSOCIATIONS

Section 9(1) of the Associations Incorporation Act is amended by omitting "section 9B" and substituting "sections 22A, 25AQ and 26A".

#### 3. REGULATIONS

Section 28(g) of the Associations Incorporation Act is amended by omitting "\$200" and substituting "\$10,000".

## 4. AMENDMENTS OF OTHER PROVISIONS

The other provisions of the Associations Incorporation Act specified in the Schedule are amended as provided for in that Schedule.
