An Act to amend the Misuse of Drugs Act

The Legislative Assembly of the Northern Territory enacts as follows:

1 Short title

This Act may be cited as the *Misuse of Drugs Amendment Act 2008*.

2 Commencement

This Act commences on the date fixed by the Administrator by *Gazette* notice.

3 Act amended

- (1) An *indigenous community* is:
 - (a) a prescribed area; or
 - (b) an area prescribed by regulation.
- (2) However, a regulation may declare a prescribed area is not an indigenous community.

prescribed area, see section 4 of the Northern Territory National Emergency Response Act 2007 (Cth).

(3) In a prosecution for an offence against subsection (2), a statement in the complaint or information that a person was in an indigenous community when the alleged offence was committed is evidence of the matters stated.
