The Legislative Assembly of the Northern Territory enacts as follows:

Part 1 Preliminary matters

1 Short title

This Act may be cited as the *Assembly Members and Statutory Officers (Remuneration and Other Entitlements) Amendment Act 2017*.

2 Commencement

- (1) Part 3 is taken to have commenced on 1 January 2017.
- (2) The remainder of this Act commences on the day fixed by the Administrator by *Gazette* notice.

Part 2 Amendment of Assembly Members and Statutory Officer (Remuneration and Other Entitlements) Act

3 Act amended
