An Act to amend the *Liquor Act*

The Legislative Assembly of the Northern Territory enacts as follows:

## 1 Short title

This Act may be cited as the *Liquor Amendment (Repeal of Minimum Pricing) Act 2018*.

## 2 Commencement

This Act commences on the day after the day on which the Administrator's assent to this Act is declared.

This Act amends the *Liquor Act*.
