NORTHERN TERRITORY OF AUSTRALIA

A BILL for AN ACT

to amend the various Acts consequential on the passing of the Medical Act 1994

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory* (Self-Government) Act 1978 of the Commonwealth, as follows:

PART 1 - PRELIMINARY

1. SHORT TITLE

This Act may be cited as the Medical (Consequential Amendments) Act 1994.

2. COMMENCEMENT

This Act shall come into operation on the commencement of the Medical Act.

3. AMENDMENT OF INTERPRETATION ACT

(1) Section 18 of the *Interpretation Act* is amended by omitting the definition of "medical practitioner".

Medical (Consequential Amendments)

(2) The Interpretation Act is amended by inserting after Section 34A the following:

"34B. REFERENCES TO MEDICAL PRACTITIONER

A reference in an Act to a medical practitioner, however described, shall be read as a reference to a medical practitioner who is entitled to practise medicine by, under or for the purposes of the Medical Act.".

4. AMENDMENT OF OTHER ACTS

The provisions of the Acts specified in the Schedule are amended as provided for in that Schedule.

- 5. AMENDMENT OF PUBLIC HEALTH (MEDICAL AND DENTAL INSPECTION OF SCHOOL CHILDREN) REGULATIONS
- (1) Regulation 2 of the Public Health (Medical and Dental Inspection of School Children) Regulations is amended by omitting the definition of "medical practitioner".
- (2) The amendment effected by this section may be repealed or further amended by regulations, as if the amendment made by this Act was duly made by regulations.
