NORTHERN TERRITORY OF AUSTRALIA

A BILL for AN ACT

to amend the *Fisheries Amendment Act 1994*

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Fisheries Amendment Act 1994 Amendment Act 1994*.

2. COMMENCEMENT

Section 2(2) of the *Fisheries Amendment Act 1994* is amended by omitting all words before "of this Act" and substituting "Sections 5(a), (b), (c) and (e), 34, 35, 36 and 37".

3. TAKING, &c., FISH, &c., WITHOUT LICENCE

Section 6 of the *Fisheries Amendment Act 1994* is amended by omitting from paragraph (b) "larva of fish" and substituting "larva of aquatic life or fish".

4. EXPIRY AND RENEWALS

Section 8 of the *Fisheries Amendment Act 1994* is amended by omitting from proposed subsection (5) "(5) The Director" and substituting "(4A) The Director".

5. REPEAL AND SUBSTITUTION

Section 10 of the *Fisheries Amendment Act 1994* is amended by omitting from proposed section 13(1) paragraphs (a), (b) and (c) and substituting the following:

- "(a) where a licensee is a natural person - the licensee or a person approved under section 14(1), for the period of approval, or, where a person whose name is entered in the licensee's record book under section 14 signs the entry, that person, for the period noted opposite his or her name in the book;
- (b) where the licensee is not a natural person or a partnership - the nominated person, or, where a person whose name is entered in the licensee's record book under section 14 signs the entry, that person, for the period noted opposite his or her name in the book;
- (c) where the licensee is a partnership - one of the partners specified in the licence, the nominated person, or, where a person whose name is entered in the licensee's record book under section 14 signs the entry, that person, for the period noted opposite his or her name in the book,".

6. APPROVALS

Section 11 of the *Fisheries Amendment Act 1994* is amended -

- (a) by omitting from proposed subsection (1) "nominated person" (wherever occurring) and substituting "approved person"; and
 - (b) by omitting from proposed subsection (4) "the person required" and substituting "the licensee, partner, nominated person or person approved under subsection (1) required".
