## NORTHERN TERRITORY OF AUSTRALIA

### A BILL for AN ACT

to revise and correct the laws of the  
Territory in minor respects

**B**E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Statute Law Revision Act (No. 2) 1993*.

2. REPEAL OF *LOANS REDEMPTION FUND ACT*

The *Loans Redemption Fund Act 1981 (No. 44 of 1981)* is repealed.

3. AMENDMENT OF *OMBUDSMAN (NORTHERN TERRITORY) AMENDMENT ACT 1988*

(1) Section 9(a) of the *Ombudsman (Northern Territory) Amendment Act 1988* is amended by inserting after "this Act" (first occurring) the words "(first occurring)".

(2) The amendment effected by subsection (1) shall be deemed to have come into operation on the commencement of the *Ombudsman (Northern Territory) Amendment Act 1988*.

4. AMENDMENT OF *PUBLIC SECTOR EMPLOYMENT AND MANAGEMENT (TRANSITION AND SAVINGS) ACT*

(1) Section 15(1) of the *Public Sector Employment and Management (Transition and Savings) Act 1993* is amended by omitting "section 56" and substituting "section 57".

(2) The amendment effected by subsection (1) shall be deemed to have come into operation immediately before the commencement of the *Public Sector Employment and Management (Transition and Savings) Act 1993*.

5. AMENDMENT OF WATER ACT

Section 109(7) of the *Water Act* is amended by omitting "for the period of the certificate or for 12 months after that commencement, whichever is the greater" and substituting ", notwithstanding the period of the certificate, until 31 December 1994".

6. AMENDMENT OF ADOPTION OF CHILDREN REGULATIONS

(1) Regulation 8A(3) of the *Adoption of Children Regulations* is amended by omitting "of a fee of 50 cents" and substituting "the prescribed fee under the *Registration of Births, Deaths and Marriages Act*".

(2) Regulation 14 of the *Adoption of Children Regulations* is repealed.

(3) Regulation 8A of the *Adoption of Children Regulations* may be repealed or further amended by regulations made under the *Adoption of Children Act* as if the amendment effected by subsection(1) of this section was made by Regulations under that Act.

7. REPEAL OF AUCTIONEERS REGULATIONS

The *Auctioneers Regulations* are repealed.

8. REVISION OF ACT

The provisions of the Acts specified in the Schedule are amended as provided for in the Schedule.
