NORTHERN TERRITORY OF AUSTRALIA

A BILL for AN ACT

to amend various Acts consequential on the passing of the Pastoral Land Act 1991

B^E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Pastoral Land (Consequential Amendments) Act 1992.

2. COMMENCEMENT

This Act shall come into operation or shall be deemed to have come into operation on the commencement of the Pastoral Land Act 1991.

3. AMENDMENTS

The provisions of the Acts specified in the Schedule are amended as provided for in that Schedule.
