The Legislative Assembly of the Northern Territory enacts as follows:

## **1 Short title**

This Act may be cited as the *Statute Law Repeals Act 2020*.

## **2 Commencement**

This Act commences on the day after the day on which the Administrator's assent to this Act is declared.

## **3 Repeal of Acts**

The Acts specified in the Schedule are repealed.

## **4 Repeal of Act**

This Act is repealed on the day after it commences.
