#### 49A Delegation by Secretary

The Secretary may, in writing, delegate any of the Secretary's powers and functions under this Act to:

- (a) a public sector employee, or a person engaged by the Territory under a contract or an arrangement of secondment by name; or
- (b) a public sector employee, or a person engaged by the Territory under a contract or arrangement of secondment, by reference to the office, position or designation held or occupied by the person; or
- (c) a public sector employee, or a person engaged by the Territory under a contract or an arrangement of secondment, from time to time holding, acting in or performing the duties of a named office, position or designation.

#### 49B Delegation by Minister

The Minister may, in writing, delegate any of the Minister's powers and functions under this Act to:

- (a) a public sector employee, or a person engaged by the Territory under a contract or an arrangement of secondment by name; or
- (b) a public sector employee, or a person engaged by the Territory under a contract or arrangement of secondment, by reference to the office, position or designation held or occupied by the person; or
- (c) a public sector employee, or a person engaged by the Territory under a contract or an arrangement of secondment, from time to time holding, acting in or performing the duties of a named office, position or designation.

## Part XI Transitional matters for Mineral Royalty Amendment Act 2021

#### 60 Transitional matters for *Mineral Royalty Amendment Act 2021*

- (1) Section 4B(1), as amended by section 4 of the *Mineral Royalty Amendment Act 2021*, applies only in relation to a royalty year that commences on or after 1 July 2021.
- (2) Section 4B(1), as in force immediately before the commencement of section 4 of the *Mineral Royalty Amendment Act 2021*, continues to apply in relation to a royalty year that commenced before 1 July 2021.

#### 7 Repeal of Act

This Act is repealed on the day after it commences.
