An Act to amend the *Police Administration Act 1978*, the *Police Administration Regulations 1994* and the *Police (Special Investigative and Other Powers) Act 2015*

The Legislative Assembly of the Northern Territory enacts as follows:

Part 1 Preliminary matters

1 Short title

This Act may be cited as the *Police Legislation Amendment Act 2022*.

2 Commencement

- (1) Parts 1 and 3 of this Act commence on the day after the day on which the Administrator's assent to this Act is declared.
- (2) Subject to subsection (3), the remaining provisions of this Act commence on the day fixed by the Administrator by *Gazette* notice.
- (3) If a provision mentioned in subsection (2) does not commence before 21 November 2023, it commences on that day.

15B Eligibility for appointment to Police Force

- (1) The Commissioner may determine the criteria for eligibility of a person for appointment to the Police Force.
- (2) A person is eligible for appointment to the Police Force if the person satisfies the criteria.
- (3) A determination under subsection (1) must be published in the *Police Gazette* as soon as practicable after it is made.

157A Disarming member

(1) A person commits an offence if:

- (a) a member is acting in the course of the member's duties and the person is reckless in relation to that circumstance; and
- (b) the member is armed with a firearm or ECD and the person has knowledge of that circumstance; and
- (c) the person intentionally engages in conduct; and
- (d) the conduct results in the member losing possession of the firearm or ECD and the person intends that result.

Maximum penalty: Imprisonment for 6 years.

(2) In subsection (1):

ECD means an electro-muscular control device designed to emit an electric current into a human body for the purposes of physical incapacitation.
