#### 1 Short title

This Act may be cited as the *Local Government Grants Commission Amendment Act 2023.*

## 23 Amendments to title of Chairperson

## 24 Timing of repeal of audit requirement

For the purposes of section 10 of the *Financial Management Act 1995*, the repeal of section 21 of this Act is taken to have had effect at the end of the financial year immediately preceding the financial year in which section 5 of the *Local Government Grants Commission Amendment Act 2023* commences.
