Division 4 Special correctional services officers

25A Special correctional services officer

- For this Division, each of the following is a **special correctional services officer**:
 - (a) a special correctional officer;
 - (b) a special probation and parole officer.

25B Special correctional officers

- (1) The Commissioner may appoint a person to be a special correctional officer if the Commissioner is satisfied the person has the qualifications, skills or experience to properly perform the functions of a special correctional officer.
- (2) A special correctional officer may exercise the powers and perform the functions of a correctional officer under this or any another Act, subject to any conditions, limitations or qualifications decided by the Commissioner.
- (3) A special correctional officer is not a public sector employee by virtue of the officer's appointment as a special correctional officer.

25C Special probation and parole officers

- (1) The Commissioner may appoint a person to be a special probation and parole officer if the Commissioner is satisfied the person has the qualifications, skills or experience to properly perform the functions of a special probation and parole officer.
- (2) A special probation and parole officer may exercise the powers and perform the functions of a probation and parole officer under this or any other Act, subject to any conditions, limitations or qualifications decided by the Commissioner.
- (3) A special probation and parole officer is not a public sector employee by virtue of the officer's appointment as a special probation and parole officer.

25D Termination of appointment of special correctional services officer

The Commissioner may, at any time, terminate the appointment of a special correctional services officer.

25E Evidence of appointment

The Commissioner must issue each special correctional services officer with evidence of the person's appointment as a special correctional services officer.
