## AMENDMENTS OF COMMERCIAL PASSENGER (MISCELLANEOUS) REGULATIONS

### 1. Commencement

(1) Regulation 3(1) comes into operation on the commencement of section 26A of the Act.

(2) Regulation 3(2), (7) and (8) comes into operation on the commencement of section 15 of the *Commercial Passenger (Road) Transport Amendment Act (No. 2) 2003*.

(3) Regulation 3(3) comes into operation on the commencement of section 38K of the Act.

(4) Regulations 3(4) and 4(1) come into operation on the commencement of section 27 of the *Commercial Passenger (Road) Transport Amendment Act (No. 2) 2003*.

(5) Regulation 3(9) comes into operation on the commencement of Part 5AA of the Act.

(6) Regulation 3(11) comes into operation on the commencement of section 23 of the *Commercial Passenger (Road) Transport Amendment Act (No. 2) 2003*.

(7) Regulation 4(2) comes into operation on the commencement of Part 5AB of the Act.

(8) Regulation 4(3) comes into operation on the commencement of Part 5B of the Act.

(9) The remaining provisions of these Regulations come into operation on the date on which these Regulations are notified in the *Gazette*.

### 2. Principal Regulations

The Commercial Passenger (Miscellaneous) Regulations are in these Regulations referred to as the Principal Regulations.

### 3. Schedule 1

(1) Schedule 1 to the Principal Regulations is amended by inserting after item 2 the following:

"2A.	Section 26A(2)	Parking or standing a taxi in a bus stop during route service hours	400".

36.	Reg 6(3)	Failing to accept hiring	100".

(8) Schedule 1 to the Principal Regulations is amended by inserting after item 40 the following:

"40A.	Reg 11A(3)	Failing to display identity card	50".

(10) Schedule 1 to the Principal Regulations is amended by omitting from item 51 "Reg 4" and "identity" and substituting "Reg 4(3)" and "identity card" respectively.

(11) Schedule 1 to the Principal Regulations is amended by inserting after item 56 the following:

"56A.	Reg 11(e)	Refusing hiring when parked in a minibus rank	100".

#### 4. Schedule 2

(1) Schedule 2 to the Principal Regulations is amended by omitting –

"Approval of communication network 30"

and substituting –

"Approval of communications or dispatch network 30".

(2) Schedule 2 to the Principal Regulations is amended by inserting after the item relating to special passenger vehicles the following:

"Annual fee for grant or renewal of licence for special function vehicle 500".

(3) Schedule 2 to the Principal Regulations is amended by adding at the end the following:

"Annual fee for grant or renewal of licence for courtesy vehicle 200".
