Chapter 14 Transitional matters for Work Health and Safety (National Uniform Legislation) Amendment Regulations 2016

834 Application of Chapter 6 to construction projects

(1) Chapter 6, as in force before the commencement, continues to apply to a construction project, the cost of which is less than \$500 000 but not less than \$250 000, if the construction phase of the project began before the commencement.

(2) In this regulation:

commencement means commencement of the *Work Health and Safety (National Uniform Legislation) Amendment Regulations 2016*.

15 Expiry of Regulations

These Regulations expire on the day after they commence.
