#### Barramundi Fishery Management Plan Amendment 2010

#### 1 Citation

This instrument may be cited as the *Barramundi Fishery Management Plan Amendment 2010*.

#### 2 Commencement

This instrument commences on 1 February 2010.

#### 3 Principal Plan amended

This instrument amends the Barramundi Fishery Management Plan.

#### 4 Amendment of clause 8 (Fishery area)

(1) Clause 8(1)(c)

to co-ordinates 7059E 86360N (Lee Point)

(2) After clause 8(4)

insert

(5) A barramundi licensee must not fish under a barramundi licence in Bynoe Harbour landwards of imaginary straight lines drawn between co-ordinates 6760E 86300N (Charles Point), co-ordinates 6490E 86180N and co-ordinates 6470E 85980N (Patterson Point) on 1:100 000 map sheets Fog Bay 4972 and Darwin 5073.

Penalty: \$10,000.

(6) A barramundi licensee must not fish under a barramundi licence in Fog Bay landwards of imaginary straight lines drawn between co-ordinates 6460E 85770N, co-ordinates 6440E 85810N, co-ordinates 6350E 85740N, co-ordinates 6390E 85700N, co-ordinates 6351E 85680N and co-ordinates 6320E 85680N on 1:100 000 map sheet Fog Bay 4972.

Penalty: \$10,000.
