1 Citation

These Regulations may be cited as the Workplace Health and Safety Amendment Regulations (No. 2) 2010.

2 Regulations amended

These Regulations amend the Workplace Health and Safety Regulations.

asbestos means the asbestiform varieties of mineral silicates belonging to the serpentine or amphibole groups of rock-forming minerals including the following:

- (a) actinolite asbestos;

- (d) chrysotile (known as white asbestos);
- (d) crocidolite (known as blue asbestos);
- (e) tremolite asbestos.
