CERTIFICATE ON PERFORMANCE OF BREATH ANALYSIS

I, *(operator name)*, a police officer authorised by the Commissioner to use a prescribed breath analysis instrument known as a Drager Alcotest 7110 for the *Traffic Act*, certify as follows:
