1 Citation

These Regulations may be cited as the *Construction Industry Long Service Leave and Benefits Amendment Regulations 2009*.

2 Commencement

- (1) These Regulations, other than regulation 5, commence on 1 July 2009.
- (2) Regulation 5 commences on 1 July 2011.

7 Transitional matters for *Construction Industry Long Service Leave and Benefits Amendment Regulations 2009*

- (1) If construction work has started before the commencement of

regulation 4 of the *Construction Industry Long Service Leave and Benefits Amendment Regulations 2009* (the **amending regulations**), the levy rate in force immediately before the commencement of that regulation applies to all that construction work (including work that takes place after that commencement).

- (2) The levy rate as amended by regulation 4 of the amending regulations applies to construction work that starts after the commencement of that regulation (including work that takes place after the commencement of regulation 5 of the amending regulations).
- (3) The levy rate as amended by regulation 5 of the amending regulations applies to construction work that starts after the commencement of that regulation.
