1. Citation

These Regulations may be cited as the *Legislative Assembly (Powers and Privileges) Regulations*.



Part AB

All that parcel of land in the Town of Darwin in the Northern Territory of Australia containing an area of 3.87 hectares more or less and bounded by lines described as follows:
