Regulations under the *Electoral Act*

ELECTORAL REGULATIONS

1. Citation

These Regulations may be cited as the Electoral Regulations.

2. Prescribed amount for infringement offence

For the definition of "prescribed amount" in section 3 of the Act, \$25 is the amount prescribed for an offence against section 279(1) of the Act.

3. Requirements of nominee's photograph for nomination

- (1) For section 32(1)(f) of the Act, a photograph of a nominee must –
- (a) be a black and white, full faced vertical portrait of the nominee's head and shoulders;
- (b) have been taken within 6 months before lodgment of the nominee's nomination; and
- (c) have endorsed on the reverse side the nominee's full name and a statement signed by the nominee certifying that the photograph was taken within the period mentioned in paragraph (b).
- (2) However, the Electoral Commission may accept a photograph of a nominee that does not comply with subregulation (1) if the Commission is satisfied the nominee is readily recognisable in the photograph.

4. Form of ballot paper

For section 40(1) of the Act, a ballot paper must be in Form 1 in the Schedule.
