**AMENDMENTS OF POLICE ADMINISTRATION (FEES)
REGULATIONS**

1. Commencement

These Regulations come into operation on the date fixed by the Minister by notice in the *Gazette*.

2. Fee for police attendance at false alarms

Regulation 2A of the Police Administration (Fees) Regulations is amended by omitting from subregulation (1) "\$100" and substituting "\$110".

3. Repeal and substitution

The Schedule to the Police Administration (Fees) Regulations is repealed and the following substituted:

| (c) a member who holds a rank below the rank of sergeant | \$28 for each half hour or part thereof (including travelling time) for each member of that rank engaged |

7. Providing a report about stolen property	\$28, plus 55c for each copy of a page of the report
8. Providing a report for the purpose of granting a passport or visa	\$28 if a search of police fingerprint files is not required and \$66 if a search of police fingerprint files is required
9. Providing photographic services	\$19, plus –
(a) for each black and white photograph, print size –	
(i) 17 cm x 12 cm	\$6.50
(ii) 25 cm x 20 cm	\$12
(iii) 50 cm x 40 cm	\$50
(b) for each coloured photograph, print size –	
(i) 10.4 cm x 15.2 cm	\$1.10
(ii) 20.8 cm x 15.2 cm	\$5.50

15.	Providing independent forensic services to clients who are not Agencies, being –	
	(a) a general forensic examination	\$110 per hour
	(b) DNA analysis	\$165 per hour
	(c) the preparation of a forensic case file	\$40, plus 55c for each copy of a page of the file
