#### AMENDMENTS OF POLICE ADMINISTRATION (FEES) REGULATIONS

#### 1. Commencement

These Regulations come into operation on the date fixed by the Minister by notice in the *Gazette*.

## 2. Fee for police attendance at false alarms

Regulation 2A of the Police Administration (Fees) Regulations is amended by omitting from subregulation (1) "\$100" and substituting "\$110".

#### 3. Repeal and substitution

The Schedule to the Police Administration (Fees) Regulations is repealed and the following substituted:
