Barramundi Fishery Management Plan

AMENDMENTS TO BARRAMUNDI FISHERY MANAGEMENT PLAN

1. Principal Plan

The Barramundi Fishery Management Plan is in these amendments referred to as the Principal Plan.

2. Commencement

These amendments come into operation on 1 July 2002.

3. Fishery area

Clause 8 of the Principal Plan is amended by adding at the end the following:

"(3) A barramundi licensee must not fish under a barramundi licence in the McArthur River system, being the areas –

- (a) landwards of an imaginary straight line extending between 1:100 000 Map Sheet PELLEW grid reference 6630E 82610N (Coastline) to 6761E 82665N (South West Island); and
- (b) landwards of an imaginary straight line extending between 1:100 000 Map Sheet PELLEW grid reference 6800E 82553N (Amos Point) to 6895E 82420N (Sharker Point)."

4. Schedule 1

Schedule 1 to the Principal Plan is amended by omitting all the words from and including "The McArthur River Holding Area" to and including "the Rocky Creek boat ramp."
