*Motor Vehicles (Fees and Charges) Amendment (Heavy Vehicles)
Regulations 2005*

1. Citation

These Regulations may be cited as the *Motor Vehicles (Fees and Charges) Amendment (Heavy Vehicles) Regulations 2005*.

2. Principal Regulations amended

These Regulations amend the *Motor Vehicles (Fees and Charges) Regulations*.

3. Amendment of regulation 2A (Definitions)

- (1) Regulation 2A, definition of "heavy vehicle" –

"heavy vehicle" means a vehicle to which the Schedule, Part 2 of the Road Transport Charges Act applies;

"Road Transport Charges Act" means the *Road Transport Charges (Australian Capital Territory) Act 1993* (Cth);

4. New regulation 3A

After regulation 3 –

3A. Registration fees for heavy vehicles

- (1) This regulation applies subject to regulation 4.

(2) The fee for registering or renewing the registration of a heavy vehicle on or before 30 June 2005 is the same as the annual registration charge for the vehicle determined under section 3A of the Road Transport Charges Act for the financial year ending on that date.

(3) The fee for registering or renewing the registration of a heavy vehicle in a financial year commencing on or after 1 July 2005 is the same as the annual registration charge for the vehicle determined under that section for the financial year.

(4) The amounts of the annual registration charges for heavy vehicles are made available to the public by the National Transport Commission under section 3A(3) of that Act.
