# Rules under the Small Claims Act

#### AMENDMENTS OF SMALL CLAIMS RULES

## 1. Principal Rules

The Small Claims Rules are in these Rules referred to as the Principal Rules.

#### 2. Repeal

Rule 21.07 of the Principal Rules is repealed.

### 3. Heading to Part 23

The heading to Part 23 of the Principal Rules is amended by adding at the end "AND APPEAL FROM ORDER OF REGISTRAR".

#### 4. Application for re-hearing

Rule 23.01 of the Principal Rules is amended -

- (a) by omitting subrule (1);
- (b) by omitting from subrule (2) "referred to in subrule (1)" and substituting "under section 20 of the Act"; and
- (c) by omitting from subrule (3)(c) "a final order" and substituting "the order that is the subject of the application".

#### 5. Repeal

Rule 23.03 of the Principal Rules is repealed.

## 6. New rules

The Principal Rules are amended by inserting after rule 23.04 in Part 23 the following:

#### "23.05 Application for leave to appeal from order made by Registrar

"An application for leave to appeal to a magistrate from an order made by a Registrar, as required by section 31(3)(b) of the Act, is to be in accordance with Form 23B.

#### "23.06 Appeal from order made by Registrar

"(1) A party who under section 31(1) of the Act appeals to a magistrate from an order made by a Registrar must file a notice of appeal in accordance with Form 23C.

"(2) A copy of a notice of appeal is to be served personally on each other party unless the Court orders otherwise.".

#### 7. Schedule 1

Schedule 1 to the Principal Rules is amended by adding at the end the following:
