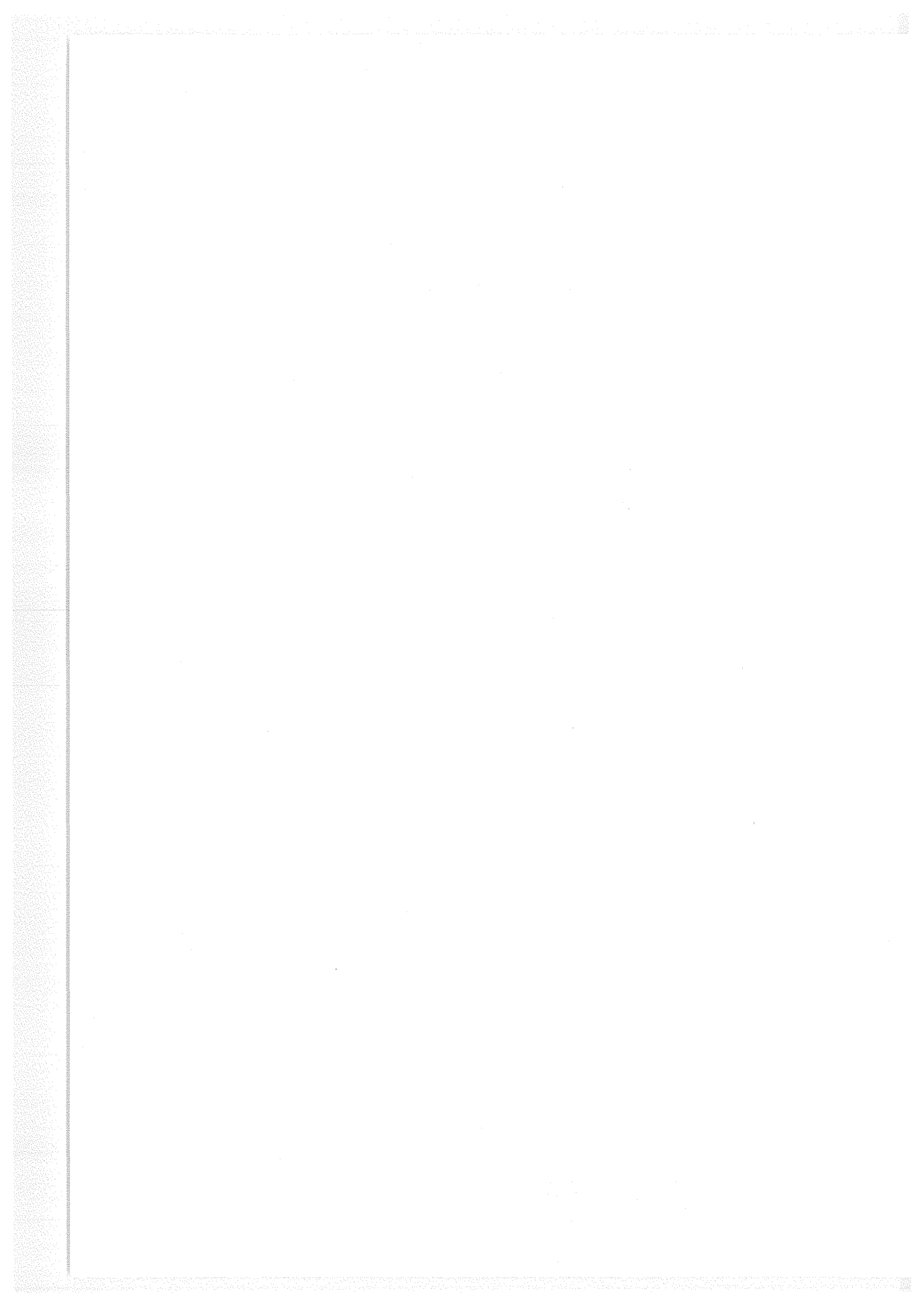

### **Regulations under the *AustralAsia Railway (Special Provisions) Act***

**AMENDMENTS OF AUSTRALASIA RAILWAY (SPECIAL PROVISIONS) REGULATIONS**

**1. Principal Regulations**

The AustralAsia Railway (Special Provisions) Regulations are in these Regulations referred to as the Principal Regulations.

**2. Commencement**

These Regulations come into operation on the day on which they are made.

**3. Definitions**

Regulation 3 of the Principal Regulations is amended –

(a) by omitting "*Act.*" from the definition of "Special Provisions Act" and substituting "*Act.*"; and

(b) by adding at the end the following:

"'Third Party Access Act' means the *AustralAsia Railway (Third Party Access) Act.*".

**4. New Part**

The Principal Regulations are amended by adding at the end the following:

**"PART 4 – AMENDMENTS OF AUSTRALASIA RAILWAY (THIRD PARTY ACCESS) ACT**

**"9. New section**

"The Third Party Access Act is amended by inserting after section 7 the following:

**" 8. Modification of Code**

"'If the designated Minister under Part IIIA of the *Trade Practices Act 1974* of the Commonwealth believes under section 44H(6) of that Act that an amendment to the Access Code made under clause 48 of the Code after the commencement of this section is, or results in, a substantial modification of the Code, then that amendment is to be taken not to be in force, and never to have been in force, to the extent of that belief.'"

**"10. Schedule**

"The Schedule to the Third Party Access Act is amended by omitting clause 48 and substituting the following:

*AustralAsia Railway (Special Provisions) Regulations*

**" 48. Amendment of Code**

" (1) This Code may be amended by the Northern Territory Minister and the South Australian Minister jointly as prescribed.

" (2) This clause expires on 30 June 2001!."
