

## Supreme Court Rules

#### AMENDMENTS OF SUPREME COURT RULES

## 1. Principal Rules

The Supreme Court Rules are in these Rules referred to as the Principal Rules.

## 2. Authority

Rule 77.01 of the Principal Rules is amended –

- (a) by inserting after subrule (1)(b)(ii) the following:
  - "(iii) the Real Property Act for the extension of a caveat;";
- (b) by omitting from subrule (1)(b)(vii) "or";
- (c) by omitting from subrule (1)(b)(viii) "and" (last occurring);
- (d) by adding at the end of subrule (1)(b) the following:
  - "(ix) the Partnership Act;
  - (x) the De Facto Relationships Act;";
- (e) by omitting from subrule (1)(c)(ii) "purchase money." and substituting "purchase money;"; and
- (f) by adding at the end of subrule (1) the following:
  - "(d) conduct the trial of a proceeding if all the parties to the proceeding consent to the Master conducting the trial;
  - (e) conduct the trial of a proceeding if the only matters in issue are the amount of damages, or the value of goods, and costs;
  - (f) conduct the trial of an action for personal injuries, which may include hearing and determining issues of liability and damages;
  - (g) hear and determine an application for the extension of a limitation period;
  - (h) hear and determine an application for the possession of land; and
  - (j) hear and determine a matter referred to the Master by the Court of Appeal or a Judge.".

## 3. Limitation on authority

Rule 77.02 of the Principal Rules is amended –

#### Supreme Court Rules

- (a) by omitting from subrule (1) "77.01(1)(b)" and substituting "77.01(1)(b), (d), (e) and (f)"; and
- (b) by omitting subrule (4)(f) and substituting the following:
  - "(f) a question of construction arising under an instrument where the sole purpose of the proceeding is to determine that question;".

## 4. Repeal and substitution

Rule 77.05 of the Principal Rules is repealed and the following substituted:

## "77.05 Appeal

- "(1) Except as otherwise provided by these Rules or an Act, a person affected by a judgment given or order made under this Chapter by the Master or a Registrar may appeal to -
  - (a) in the case of a final judgment or order a Judge; or
  - (b) in the case of an interlocutory judgment or order a Judge but only with the leave of a Judge.
  - "(2) An appeal under this rule is an appeal in the strict sense.".

## 5. Appeal from Master

Rule 78.07 of the Principal Rules is amended by omitting "Rules 77.05 and 77.06 apply" and substituting "Rule 77.05 applies".

## 6. Repeal and substitution

Rule 83.04 is repealed and the following substituted:

## "83.04 Time for appeal

"An appeal is to be instituted within 28 days after –

- (a) the material date; or
- (b) the date on which leave to appeal is granted.".

## 7. Time for filing application

Rule 83.23 of the Principal Rules is amended by omitting from subrule (1)(a) "28 days" and substituting "7 days".
