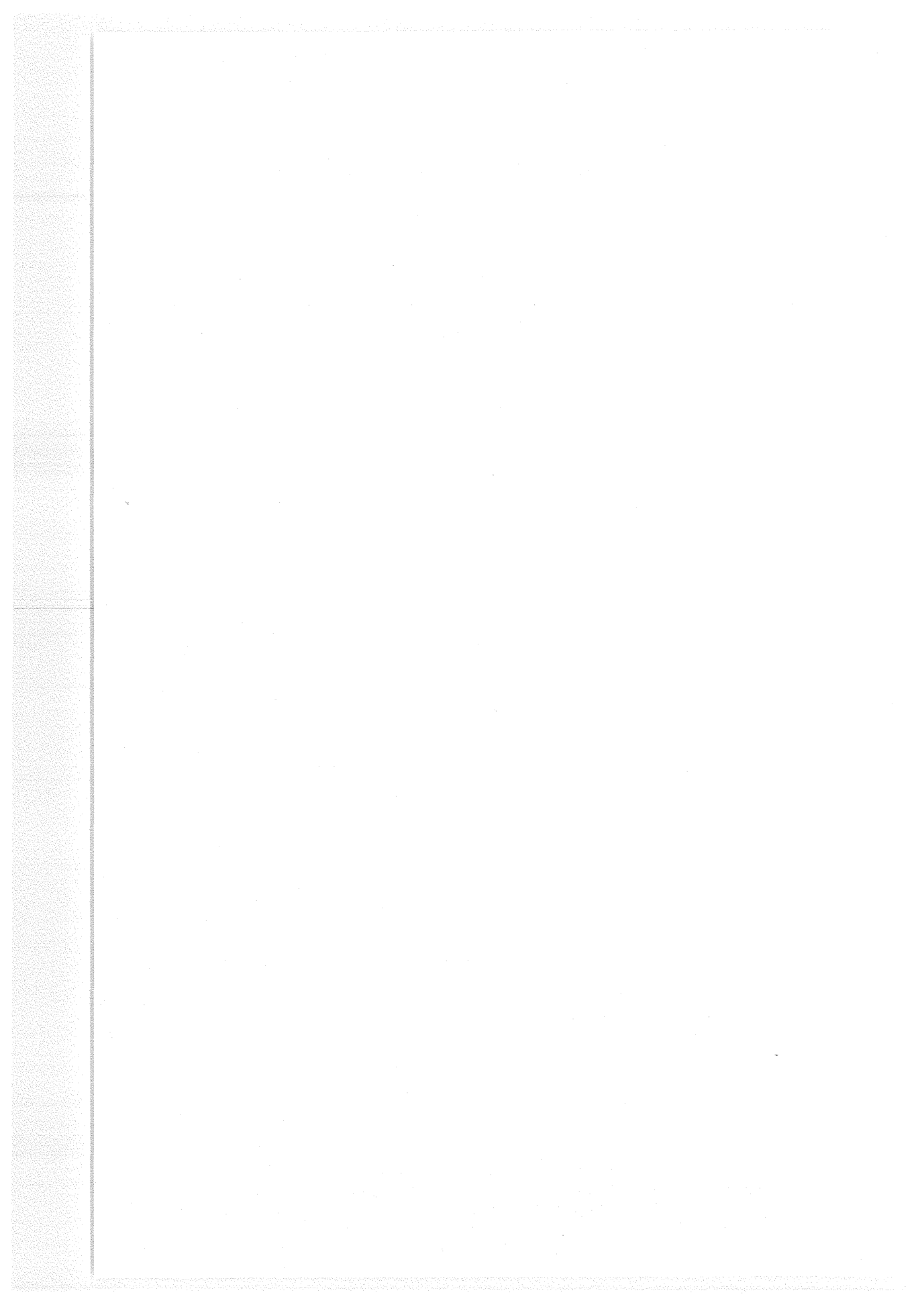

## **Regulations under the *Motor Vehicles Act***

**AMENDMENTS OF MOTOR VEHICLES REGULATIONS**

**1. Principal Regulations**

The Motor Vehicles Regulations are in these Regulations referred to as the Principal Regulations.

**2. Definitions**

Regulation 4A of the Principal Regulations is amended –

- (a) by omitting the definition of "gross combination mass";
- (b) by omitting the definition of "gross vehicle mass";
- (c) by omitting "cycle;" from paragraph (b) of the definition of "motor cycle" and substituting "cycle."; and
- (d) by omitting the definition of "vehicle combination".

**3. Classification of licences**

Regulation 4AA of the Principal Regulations is amended –

- (a) by omitting paragraphs (d) and (e) from the column headed "Type of Vehicle" opposite classification C in the table to subregulation (1) and substituting the following:

- "(d) a motor omnibus;
- (e) a special passenger vehicle; or
- (f) a minibus"; and

- (b) by omitting subregulation (4)(d) and (e) and substituting the following:

- "(d) HR;
- (e) HC;
- (f) MC."

**4. Fees for inspection of record of registrations and licences**

Regulation 15 of the Principal Regulations is amended –

- (a) by omitting "A person" and substituting "(1) Subject to subregulation (2), a person"; and
- (b) by adding at the end the following:

*Motor Vehicles Regulations*

"(2) An officer having duties in connection with the registration or licensing of vehicles in a State or another Territory of the Commonwealth may be furnished, free of charge, with information relating to registration or licences."

**5. Schedule**

Forms N and O in the Schedule to the Principal Regulations are omitted.
