# Regulations under the Work Health Act

#### Work Health Regulations

#### AMENDMENTS OF WORK HEALTH REGULATIONS

#### 1. Principal Regulations

The Work Health Regulations are in these Regulations referred to as the Principal Regulations.

#### 2. Repeal

Regulation 3 of the Principal Regulations is repealed.

#### 3. Definition of "worker"

Regulation 3A of the Principal Regulations is amended by omitting from subregulation (2) "paragraph (g)" and substituting "paragraph (b)(vii)".

#### 4. Prescribed amount

Regulation 5 of the Principal Regulations is amended by omitting "(d)".

### 5. Compensation for certain volunteers

Regulation 8 of the Principal Regulations is amended by inserting "or her" after "his".

## 6. Repeal

Regulation 10 of the Principal Regulations is repealed.

# 7. Medical certificate to accompany claim

Regulation 12 of the Principal Regulations is amended -

- (a) by omitting subregulation (1);
- (b) by omitting from subregulation (2) "referred to in subregulation (1) shall" and substituting "for the purposes of section 82(1)(b) of the Act is to"; and
- (c) by omitting from subregulation (3) "subsection (1)" and substituting "subregulation (2)".

# 8. Repeal and substitution

Regulation 13 of the Principal Regulations is repealed and the following substituted:

#### "13. Statement of right to commence proceedings before Court

"If the employer gives the worker a statement referred to in section 69(1)(b) or 85(8) of the Act, the employer must also give the worker—

- (a) a copy of the statement: and
- (b) a copy of the approved information bulletin relating to the mediation process."

#### 9. Repeal and substitution

Regulations 14A and 14B of the Principal Regulations are repealed and the following substituted:

#### "14A. Procedure for mediation

- "(1) A mediator must keep a record of the mediation of a dispute that includes
  - (a) a description of the nature of the dispute;
  - (b) the parties to the mediation; and
  - (c) the outcome of the mediation.
- "(2) If a mediator convenes a conference under section 103C(3)(b) of the Act, the mediator—
  - (a) must set the date on which, and the time and place at which, the conference is to take place;
  - (b) must preside at the conference; and
  - (c) may adjourn or terminate the conference at any time.".

#### 10. Employer's wages declarations

Regulation 16 of the Principal Regulations is amended by omitting subregulation (1).

#### 11. Repeal

The Schedule to the Principal Regulations is repealed.
