AMENDMENTS OF MINING REGULATIONS

1. Principal Regulations

The Mining Regulations are in these Regulations referred to as the Principal Regulations.

2. Repeal

Regulations 4 and 5 of the Principal Regulations are repealed.

3. Repeal and substitution

Regulation 11A of the Principal Regulations is repealed and the following substituted:

"11A. Form of approval to enter land

"For the purposes of sections 11(1)(b) and 83(4) of the Act, an approval of a warden to enter land is to be in accordance with Form 2."

4. Method of marking out

Regulation 19 of the Principal Regulations is amended by omitting from subregulation (1) "shall, before such an application is made, be taken possession of and marked out in the following manner:" and substituting "is to be marked out in the following manner:".

5. Repeal and substitution

Regulation 28 of the Principal Regulations is repealed and the following substituted:

"28. Time for marking out and making application for mineral claim

"(1) A person making an application for a mineral claim must before making the application mark out the area that is the subject of the application.

"(2) The person must lodge the application for the mineral claim at the prescribed mining registrar's office –

- (a) within 14 days after completing marking out of the area the subject of the application; or
- (b) within any longer period allowed by the prescribed mining registrar.

"28A. Time for marking out and completing application for extractive mineral lease

"(1) A person making an application for an extractive mineral lease must mark out the area the subject of the application –

- (a) within 14 days after receiving the Minister's approval to submit the application for the extractive mineral lease to the Minister; or
- (b) within any longer period allowed by the prescribed mining registrar.

"(2) When the person completes the marking out, the person must lodge at the prescribed mining registrar's office sufficient details in respect of the area marked out to demonstrate that the marking out complies with regulation 19.

"(3) The person must lodge the details –

- (a) within 14 days after the marking out is completed; or
- (b) within any longer period allowed by the prescribed mining registrar.

"28B. Time for marking out and completing application for extractive mineral permit

"(1) A person making an application for an extractive mineral permit must mark out the area the subject of the application –

- (a) within 14 days after receiving the Minister's approval to submit the application for the extractive mineral permit to the Minister; or
- (b) within any longer period allowed by the Secretary.

"(2) When the person completes the marking out, the person must lodge at the office of the Secretary sufficient details in respect of the area marked out to demonstrate that the marking out complies with regulation 19.

"(3) The person must lodge the details –

- (a) within 14 days after the marking out is completed; or
- (b) within any longer period allowed by the Secretary."

6. Schedule 4

Schedule 4 to the Principal Regulations is amended by omitting Form 2 and substituting the following:
