**AMENDMENTS OF MOTOR VEHICLES (FEES AND CHARGES)  
REGULATIONS**

**1. Principal Regulations**

The Motor Vehicles (Fees and Charges) Regulations are in these Regulations referred to as the Principal Regulations.

**2. Definitions**

Regulation 2A of the Principal Regulations is amended –

- (a) by inserting after the definition of "classic" the following:

" 'corporate number plate' means a number plate that is to be issued to a corporation or other organisation and that displays a logo or other letters or figures, in colours chosen by the corporation or organisation, identifying the corporation or organisation;"; and

- (b) by inserting after the definition of "heavy vehicle" the following:

" 'slimline number plate' means a number plate that is to be issued in respect of a particular motor vehicle and that is narrower than the number plates determined by the Registrar to be affixed to motor vehicles belonging to the same class of motor vehicle as that motor vehicle;".

**3. Schedule**

The Schedule to the Principal Regulations is amended –

- (a) by omitting from item 6 "Replacement of damaged or defaced number plates:" and substituting "Replacement of damaged or defaced number plates that are not corporate number plates or slimline number plates:";

- (b) by inserting after item 6 the following:

"6A. Replacement of damaged or defaced           17(2)   \$25.00  
corporate number plates or slimline  
number plates";

- (c) by omitting from item 7 "Replacement of number plates declared lost or destroyed:" and substituting "Replacement of number plates declared lost or destroyed that are not corporate number plates or slimline number plates:";

d) by inserting after item 7 the following:

"7A.	Replacement of corporate number plates or slimline number plates declared lost or destroyed";	18(2)	\$25.00

(e) by omitting from item 24 "number plates" and substituting "number plates other than corporate number plates "; and

(f) by inserting after item 24 the following:

"24A. Issue of corporate number plates:

(a) for first pair of corporate number plates	138(1)(af)	\$300.00 plus cost of plate design and set up

(b) per each subsequent pair of corporate number plates".	138(1)(af)	\$150.00
