AMENDMENT OF POLICE ADMINISTRATION (FEES) REGULATIONS

1. Commencement

These Regulations come into operation on the date fixed by the Minister by notice in the *Gazette*.

2. Repeal and substitution

The Schedule to the Police Administration (Fees) Regulations is repealed and the following substituted:

FEES FOR PROVISION OF OTHER SERVICES

Column 1 Services	Column 2 Fees
1. Providing an escort	For each member engaged, \$100 for the first 2 hours or part thereof plus \$25 for each half hour or part thereof after the first 2 hours
2. Performing special guard duty	\$25 for each half hour or part thereof for each member engaged
3. Providing services in respect of a sporting or entertainment event where duties are carried out by –	
(a) a member who holds a rank above the rank of senior sergeant	\$35 for each half hour or part thereof (including travelling time) for each member of that rank engaged
(b) a member who holds the rank of senior sergeant or sergeant	\$30 for each half hour or part thereof (including travelling time) for each member of that rank engaged
(c) a member who holds a rank below the rank of sergeant	\$25 for each half hour or part thereof (including travelling time) for each member of that rank engaged

Police Administration (Fees) Regulations

4. Providing a support service in respect of a sporting or entertainment event, being—
 - (a) a police horse \$20 for each half hour or part thereof (including travelling time) for each horse
 - (b) a police motorcycle \$20 for each half hour or part thereof (including travelling time) for each motorcycle
 - (c) a police car or van \$20 for each half hour or part thereof (including travelling time) for each car or van
 - (d) a police motor boat that is—
 - (i) a single engine motor boat \$15 for each half hour or part thereof (including travelling time) for each motor boat of that kind
 - (ii) a twin engine motor boat \$75 for each half hour or part thereof (including travelling time) for each motor boat of that kind
 - (e) a police aircraft \$250 for each half hour or part thereof (including travelling time) for each aircraft
5. Interviewing a member for the purpose of acquiring information about an accident \$25 for each half hour or part thereof for each member interviewed
6. Providing a report about an accident \$25, plus 50c for each copy of a page of the report
7. Providing a report about stolen property \$25, plus 50c for each copy of a page of the report
8. Providing a report for the purpose of granting a passport or visa \$25 if a search of police fingerprint files is not required and \$60 if a search of police fingerprint files is required

9. Providing photographic services \$17, plus –
- (a) for each black and white photograph, print size –
- (i) 17 cm x 12 cm \$6
- (ii) 25 cm x 20 cm \$11
- (iii) 50 cm x 40 cm \$46
- (b) for each coloured photograph, print size –
- (i) 10.4 cm x 15.2 cm \$1
- (ii) 20.8 cm x 15.2 cm \$5
- (iii) 25 cm x 20 cm \$10
- (iv) 50.8 cm x 40.6 cm \$40
- (c) for the development of a negative \$7
- (d) for a copy of a photograph \$9
- (e) for any other photographic work the current market price as determined by the member in charge of the forensic science section of the Police Force
10. Photocopying a document 50c for each copy of a page of the document
11. Providing an electronic copy of an electronically recorded record of interview or witness statement, being –
- (a) a video tape \$10
- (b) an audio tape \$5
12. Processing an application under section 9 of the *Prostitution Regulation Act* and providing a certificate under that section \$60

| (c) the preparation of a forensic case file | \$35, plus 50c for each copy of a page of the file |
