# AMENDMENTS OF HOUSING (GOVERNMENT EMPLOYEES) SALES SCHEME REGULATIONS

#### 1. COMMENCEMENT

These Regulations come into operation on the commencement of the Housing Amendment Act 1998.

#### 2. SCHEDULE

The Schedule to the Housing (Government Employees) Sales Scheme Regulations is amended —

- (a) by omitting from clause 12(1) "approved form to the Commission" and substituting "approved form to the Chief Executive Officer (Housing)";
- (b) by omitting from clause 12(1)(d) "from the Commission" and substituting "from the Chief Executive Officer (Housing)";
- (c) by omitting from clause 12(2) "Commission" and substituting "Chief Executive Officer (Housing)";
- (d) by omitting from clause 22 "Commission" (first occurring) and substituting "Chief Executive Officer (Housing)"; and
- (e) by omitting from clause 22(a)(ii) "opinion of the Commission" and substituting "opinion of the Chief Executive Officer (Housing)".
