Regulations under the Private Security Act

PRIVATE SECURITY (SECURITY FIRMS) REGULATIONS

1. CITATION

These Regulations may be cited as the Private Security (Security Firms) Regulations.

2. DISQUALIFYING OFFENCES

For the purposes of the definition of "disqualifying offence" in section 3 of the Act, an offence against section 161, 162, 163, 165, 166, 177, 181, 182, 186, 188, 189A, 189, 192, 192B, 193, 194, 195, 196, 211, 212, 227, 228, 229, 230, 231 or 233 of the Criminal Code is prescribed in relation to a security firm's licence.

3. FORM

For the purposes of section 14(1) of the Act, the prescribed form for an application for a security firm's licence is the form in the Schedule.

4. INFORMATION TO BE PROVIDED BY APPLICANT

For the purposes of section 14(5) of the Act, the following information is prescribed in relation to an application for a security firm's licence:

* Notified in the Northern Territory Government Gazette on 4 August 1998.

- (a) 2 identical current passport-sized photographs; and
- (b) the fingerprints of, where the applicant is -
 - (i) a natural person the applicant;
 - (ii) a partnership each partner in the partnership; or
 - (iii) a corporation each officer, within the meaning of section 17(1) of the Act, of the corporation.

5. FEES

(1) For the purposes of section 18(6) of the Act, the fee for the grant of a security firm's licence is -

- (a) where the applicant is a natural person \$400;
- (b) where the applicant is a partnership \$400 for each partner; and
- (c) where the applicant is a corporation \$800.

(2) For the purposes of section 24(2) of the Act, the fee for the renewal of a security firm's licence is -

- (a) where the applicant is a natural person \$400;
- (b) where the applicant is a partnership \$400 for each partner; and
- (c) where the applicant is a corporation \$800.
