AMENDMENTS OF COMMERCIAL PASSENGER
(MISCELLANEOUS) REGULATIONS

1. COMMENCEMENT

These Regulations come into operation on the date the *Commercial Passenger (Road) Transport Amendment Act 1998* commences.

2. SCHEDULE 1

(a) by omitting item 1 and substituting the following:

(h) by adding at the end the following:
